Motion by Gibson, seconded by Glenn to remove Alan D. Bahnsen and Robert A. Sestak from the Adams Bank & Trust Account # 2537995 and close this fund and add the funds to Account # 21848. All voting yes.

Motion by Dickmander, seconded by Gibson to add David Spencer, Tamera Loomis, Mike Gibson and Thaddeus Glenn to Adams Bank & Trust account #'s: 21848,2626509, 7206634 and in accordance with Neb. Rev. Stat. 17-711, both the village board chairman and the village clerk must sign all warrants drawn on the village treasurer. All voting yes.

Motion by Glenn, seconded by Dickmander to approved Adams Bank & Trust "Business" Access to Tamera Loomis for account # 21848 to conduct business as necessary and process monthly ACH transactions. All voting yes.

Motion by Gibson, seconded by Glenn to approve Gross Payroll for Seth Godbey \$1,906.68 and Tamera Loomis \$470.20 for each payday 2/15/25 and 2/28/25. All voting yes.

Motion by Gibson, seconded by Glenn to post the Village Board of Trustee vacancy at the post office, bank, village office, and community hall. All voting yes.

Public Comment: Bandon Bullock addressed the board.

Motion by Dickmander, seconded by Gibson to enter into closed session for purpose of reviewing Village Clerk applications to include members of the village board and the village attorney at 7:28. All voting yes.

Motion by Dickmander, seconded by Gibson to return to open session at 8:17. All voting yes.

Motion by Dickmander, seconded by Glenn to hire Tamera Loomis as the part-time Village Clerk/Treasurer for the Village of Brule. Glenn, Spencer, and Dickmander voting yes. Gibson voting no. Motion Carried.

Motion by Glenn, seconded by Dickmander to set the rate of pay at \$23.51/hour and not to exceed 20 hours per week for the Village Clerk/Treasurer. Glenn, Dickmander, and Spencer voted yes. Gibson voted no. Motion carried.

Discussion was held about a deputy clerk position in the future.

Motion by Dickmander to adjourn at 8:32, seconded by Glenn. All voting yes, Motion Carried.
